





Environmental Division

The Environmental Department is the largest department within the Jefferson County General Health District operations. This department provides public health services to the entire Jefferson County area, including, but not limited to, the cities of Toronto and Steubenville. 2019 was another busy year for this division.

SEWAGE PROGRAM

Inspection/Permitting/Monitoring

Jefferson County General Health District Registered Sanitarians (RS) and Sanitarians-in-Training (SIT) inspect residential and commercial sewage treatment systems to ensure that the waste these systems generate does not pollute waters of the state or the ground water supply that residents rely on for safe drinking water. This includes ongoing monitoring of existing residential and commercial treatment systems.

The Jefferson County General Health District is responsible for the following inspection/registration activities within the boundaries of Jefferson County:

- *Point of Sale program*: In Jefferson County, any time a home is sold having a septic system, the system must be inspected prior to the closing of the sale. This is generally referred to as the "Point of Sale Program".
- Permit issuance: Installation, repair or replacement of septic systems.
- Septage hauler registration: Septage trucks providing septic services within Jefferson County must be inspected and registered. After the process of removing materials from septic systems, the contractors provide the department with a written update on the condition of each septic system they service.
- Septic to public sewer conversion: In the case of communities converting from individual septic to community systems, a plumbing inspector ensures all connections are completed according to code. Upon completion of the connection to a community system, each individual system must be crushed and backfilled. The Environmental Director ensures this has been completed.

SEMI-PUBLIC SEWAGE TREATMENT SYSTEMS

A total of 69 Semi-Public Sewage Treatment Systems were registered in 2019. These systems require annual inspection and all were completed in 2019.

PRIVATE WATER SYSTEMS

Registered Sanitarians and Sanitarians-in-Training from the Jefferson County General Health District inspect the construction of private water systems and collect water samples to ensure that water being consumed is free of bacterial contamination and therefore is safe to drink.

The Jefferson County General Health District is responsible for the following water inspection/ sample collection activities within the boundaries of Jefferson County:

- Point of Sale program: In Jefferson County, any time a home is sold having a well, the system must be inspected prior to the closing of the sale. This is generally referred to as the "Point of Sale Program".
- New well construction/installation.
- Existing wells.

FOOD PROGRAM

The Food Protection Program works to ensure the safety of food prepared, served and sold throughout Jefferson County through inspections, enforcement and education. The food program year runs from March 1, 2019 through February 29, 2020. The food program has two branches of regulatory bodies that provide oversight. The Ohio Department of Health oversees food service operations and the Ohio Department of Agriculture oversees retail food establishments.

The inspections help to provide residents with safe food that is served at restaurants, retail food establishments, mobile food operations, and temporary food events located in our county.

At the end of December 2019, the environmental division had completed 707 total inspections. The food program had 523 standard inspections, 107 process review/critical control point inspections, and 28 follow up inspections.


The mobile and temporary food portion of the program completed the year with 44 mobile inspections and five temporary inspections.

These inspections represent a snapshot at the time the inspection is conducted. We take complaints against food operations very seriously and conduct additional inspections of facilities when complaints are filed with our department.

The Registered Environmental Health Specialist (REHS) is responsible for this program, which takes an average of 43% of their REHS time spent.

PUBLIC HEALTH NUISANCE INVESTIGATION

A total of 85 public health nuisance investigations were conducted in 2019. The appendix details the locations of the nuisance investigations.

PUBLIC SWIMMING POOLS




The Jefferson County General Health District inspects all public swimming pools at least twice annually to minimize the potential for disease transmission, prevent injury and provide a safe swimming

environment.

A total of 17 swimming pools were licensed in 2019. Thirteen of the 17 are outdoor pools and the remaining four are indoor pools. Annual inspection is required. Thirty-two inspections were conducted in 2019. Two swimming pool facilities were closed during the year for violations and required follow up visits. These closures were both the result of residents voicing concerns which our Environmental team validated and closed the pools until the violations were remediated.

REPORTED ANIMAL BITE EVENTS

A total of 95 reported animal bite events occurred in 2019. Eighty-one events involved dogs, 12 events involved cats, the remaining two events fall under the category of "other".

SCHOOLS/CORRECTIONAL FACILITIES

Schools and correctional facilities are inspected annually for general safety and cleanliness to ensure that they meet minimum health and safety standards. Twenty-seven schools and two corrections facilities were inspected. As with our pools and restaurant inspections, in addition to the regulatory inspections, we also serve the safety of the community through the performance of additional inspections for complaints.

SOLID WASTE PROGRAM



One of the most well-known areas of our Environmental Division is our Solid Waste Program. The Solid Waste program is an optional program of local health departments. We are on the Ohio

Environmental Protection Agency's solid waste approved list of health departments. As such, we partner with the Environmental Protection Agency (EPA) to provide local operational enforcement of the EPA regulations. The Jefferson County Health Department regularly inspects Municipal Solid Waste Landfills, CD&D Landfills, Residual Landfills, scrap tire generators and infectious waste generators. Sanitarians also inspect solid waste haulers that are registered to haul solid waste in Jefferson County. Nuisances such as tire dumps, garbage and open dump sites are also addressed through our Solid Waste Program.

TATTOO PARLOR LICENSES

Seven tattoo parlors were licensed in 2019. Two annual inspections are required. A total of 14 inspections were conducted. Additionally, on August 30, 2019, the Jefferson County General Health District partnered with the Wintersville Police and the Jefferson County Adult Probation Division and closed an illegal tattoo operation in the village of Wintersville. The operators admitted to performing services on both adults and minors without a license or proper sanitation facilities. A resident tip via Facebook provided us with the lead and we worked with authorities to seize the equipment and cease the operations thus preventing the potential spread of disease through unsanitary operations.

CAMPGROUND LICENSING



Campgrounds are inspected at least twice annually to ensure the general health and safety of patrons to our campgrounds within Jefferson County.

A total of eight Parks/Camps were licensed in 2019. Five were combined Parks/Camps and three were Recreational Vehicle Parks. Two annual inspections are required. A total of 16 inspections were conducted.

WIC



Jefferson County General Health District is proud to provide the Women, Infants, and children's Supplemental Nutrition Program (WIC) for eligible residents of Jefferson County. As per the Ohio Department of Health:

"The program improves pregnancy outcomes by providing or referring to support services necessary for full-term pregnancies; reduces infant mortality by reducing the incidence of low birth weight (infants under 5 ½ pounds are at greater risk of breathing problems, brain injuries and physical abnormalities), and provides infants and children with a healthy start in life by improving poor or inadequate diets."

The WIC program helps income eligible pregnant and breastfeeding women, women who recently had a baby, infants, and children up to five years of age who are at health risk due to inadequate nutrition. Fathers and other custodial caregivers are also able to receive education and services for their eligible child or children.

Dig, Plant, Grow



The Health District hosted a Dig, Plant, Grow event for WIC participants and community members. The event was held in early June, right in time to take advantage of prime growing season for the Ohio Valley area.

Participants learned how to grow selected plants, even in small spaces. Pots, plants, soil and seed were provided for the activity. While education on the health benefits of eating more vegetables was provided, families worked together to plant their own favorite vegetables. Care instructions for the plants were given, after which the families were encouraged to take them home to establish their own garden. A healthy veggie based lunch was served to reinforce the benefits of fresh vegetables.

Breastfeeding Awareness Month



August is designated as Breastfeeding Awareness Month. Recognizing the part breastfeeding plays in public health, WIC promotes breastfeeding as not just the healthiest way, but the natural way to feed a baby.

Jefferson County General Health District WIC Department honored our breastfeeding mothers with a luncheon and community baby shower on August 15, 2019. Various community agencies, hospitals and doctors who serve pregnant women and/or children were invited as well as the general public. Participants were provided the opportunity to engage and receive information from multiple healthcare providers in an out of office, less formal setting. One pediatrician graciously shared her story of breastfeeding her own baby with those interested in learning more about breastfeeding. Breast feeding attendees were offered nursing supplies including bras, covers, pump parts, milk storage bags and more. Many of the attending agencies provided raffle baskets as well. The event also provided an opportunity for members of the community to be exposed to and interact with breastfeeding moms. This type of interaction helps to normalize the act of breastfeeding.

Snacks with Santa



A "Snacks with Santa" event was held on December 19, 2019. WIC participants as well as the general public were invited to enjoy a health snack while visiting with the guest of honor—Santa. The snacks included healthy choices such as bagels, yogurt and fruit. Each child received a treat bag with fruit, coloring book and crayons, toothbrush and toothpaste to promote dental health. Participants in the event got to engage in a fun Christmas craft and have pictures taken with Santa. Photos were offered to those who wished to receive them. Adult participants received education via instructional handouts/literature on healthy eating during the holidays and cookie alternatives.

Final Disposition of individuals who passed in Jefferson County

In 2019, there were 427 individuals buried (49%), 440 individuals cremated (51%) and three individuals whose bodies were donated for scientific studies that occurred in the

Jefferson County Health District. Cremation has taken over as the most utilized method of final disposition for individuals in Jefferson County.

Cause of Death

Deaths among younger residents of the district are often from accidents and by suicide. Middle age and older individuals' deaths have historically been attributed to cardiac incidents and various types of cancer.

In 2019, there were 30 accidents recorded as the manner of death. Out of those 30 accidental deaths, 28 were caused by drug overdoses. Common causes of overdose were usage of Cocaine, Benzodiazepines, Oxycodone, Cannabinoid, Opiates, Amphetamines, Buprenorphine, Heroin, Sub Oxone, Methadone and Fentanyl.

Child Mortality Review

The Child Mortality Review Board met on March 19, 2019 and reviewed three cases. This is a decline from the previous year of nine cases. Four cases of child fatality were scheduled to be reviewed. One fatality was unable to be reviewed due to a pending cause of death. That case will be reviewed at the 2020 meeting.

Nursing

Vaccine for Children



The Vaccine for Children program had a successful year, reaching 836 children in our county. This program has allowed our department to help families who have no insurance or are underinsured, and keeps children

on schedule with their immunizations. Our goal is to have all children fully vaccinated by age two. We utilize an online registry for immunizations. "Impact SIIS" includes a reminder/recall system that helps to encourage parents to return to finish their children's regularly scheduled vaccines on time.

Cribs for Kids

A grant from the Ohio Department of Health has allowed us to provide 30 "pack and play" beds. These convertible bassinettes provide a safe play and sleep area for infants up to 1 year old. They also accommodate sleeping needs when traveling away from home. Qualified families are educated on the ABCs of proper use: baby sleeps alone, on their back and in their crib. During the learning, families are also trained on a safe sleep environment and provided with a "Sleep Sack" which is the preferred method of warming a baby to prevent Sudden Infant Death Syndrome (SIDS) from blanket use. Infant mortality has held at a steady rate in Ohio since 2015. By educating parents and families and providing a safe sleep kit, we hope to see a decline in these numbers. Our department partnered with Belmont, Harrison and Carroll counties in this project, and delivered a total of 53 pack and play sets to families in those surrounding counties. The combined total of the project is 83 units distributed in 2019.



Bureau for Children with Medical Handicaps

Our Bureau for Children with Medical Handicaps has 80 clients. Our Public Health Nurse visits clients with a Letter of Approval for Treatment, Diagnostic, and Service Coordination. The PHN visits clients for a comprehensive checkup at least once yearly and to advocate for client and family with connecting to financial assistance and other resources for care. Acting as a case manager/family medical advocate for the patient, our Public Health Nurse provides a full range of services to the family to assure that they are connected to the full range of clinicians and medical equipment needed for their diagnosis.

Flu Clinic Outreach




It's always better to prevent a disease than to treat it after it occurs. With that in mind, the nursing division conducted nine off-site influenza vaccine out-reach clinics. Traveling out into the field and visiting job sites makes it easier for people in our community to easily access the flu shot and they are more likely to get it for this season. Our primary goal is to see that the community is vaccinated, to that end; we outsourced many of our flu clinics in 2019. Our new medical director was not credentialed to be able to bill insurance and rather than ask our patients to pay cash, we utilized our social media network and encouraged the use of other vaccine outlets. That is the reason for our decline in adult vaccinations in 2019. We have joined a collaborative with the state for electronic medical records which includes a rendering physician for billing immunizations as of January 6, 2020, thus eliminating this concern in 2020.



Communicable Disease Reports

Sexually transmitted infections (STI) overall continue to rise in Jefferson County, and we maintain ongoing efforts to identify those affected and provide patients with effective treatment and support. Our cases of gonorrhea did drop slightly from 70 in 2018 as well as our Hepatitis C which are down from 131 in 2018. We continue to educate, screen, treat and offer free condoms in efforts to continue to decrease the STI cases.







Hepatitis A

As a community, Jefferson County experienced the Hepatitis A outbreak that was common in areas of risk. Risk factors include: homelessness, drug use, recent incarceration, and other socio-economic factors common to areas hit by the Opioid Crisis. Our first case was reported in May 2019 with a food service worker. Throughout the summer, our cases continued to climb and we responded with a multi-pronged plan of attack. We executed a large public campaign in print, broadcast and social media about the crisis as well as how handwashing was critical. We produced special handouts and educational flyers for our restaurants.

Additionally, we offered a seminar in partnership with the Ohio Department of Health. Brandi Taylor, Epidemiologist for the Outbreak, Response and Bioterrorism Investigation Team, and Theresa Bonn, an Adolescent and Adult Immunization Analyst were brought in to speak to our community partners that included hospital staff, medical office staff, infection control nurses, and law enforcement officers attended to learn what they could do in their roles. We also utilized the vaccines available through the state program to offer clinics in the evenings, weekends, and at meal times at the shelters in the community. Our July caseload was 12, in August we had 10 and by September, our cases dropped to one. We finished the year with 32 cases. Our decisive action in the summer quickly stopped the spread.

- Performed a Table Top Exercise (TTX) involving a Novel Pandemic Flu Virus with the Jefferson County Healthcare partners and Harrison County General Health District in November.
- Successful deployment of the Mobile Clinic during the Jefferson County Fair.
- Attended multiple trainings with ODH and Texas A & M Engineering Extension Services (TEEX).
- Received the Homeland Security Exercise and Evaluation Program (HSEEP) certification.
- Assisted the Nursing Division with delivering the Hepatitis A Vaccine to several organizations.

Why Public Health Emergency Preparedness?

The origins of the Public Health Emergency Preparedness program arose after the tragic attacks on the World Trade Center in New York City. From numerous Anthrax attacks throughout the years to the deadly events of September 11, 2011, Congress kicked into action and established a program that would help health departments across the nation to prepare for emergencies.

It has been 18 years since the Center for Disease Control (CDC) initiated the Public Health Emergency Preparedness (PHEP) Program.

Every year since, the PHEP program has provided vital resources to ensure communities can effectively respond to infectious disease outbreaks, natural disasters, and chemical, biological, radiological, or nuclear events.

How has PHEP helped so far?

In 2019, PHEP provided \$551,183 million across public health departments to improve response readiness. Ohio's 88 counties received \$9,489,815 to support emergency preparedness readiness. About 40% of funds went to support epidemiologists (disease detectives), lab staff, planners, and other preparedness staff on the ground. In the future, The CDC will continue to support PHEP awardees by sharing technical expertise, best practices, and lessons learned, along with tools and resources to identify and address any gaps.

Quality Improvement

Jefferson County General Health District has committed to engage in a program of continuous quality improvement.
