CALL TO ORDER

The meeting was called to order at 8:15 a.m. by Dr. Macedonia, President. The Pledge of Allegiance was recited. All board members were in attendance with the exception of Jean-Philippe Rigaud whose absence was approved.

Dr. Macedonia requested that Matt Grimshaw CEO of Trinity Hospital call in and give a Covid update as it pertains to the hospital. He denoted that of the testing that is performed weekly 15 – 20% of the tests are positive. They are tracking admission trends and census. Over the weekend the admissions dipped slightly then on Monday and Tuesday admissions continued to increase. 25% of the hospitalized patients are vaccinated. The vaccine is making a difference on hospitalization rate and the acuity of the patients.

Staffing remains to be an issue as it does across the country. Census has remained consistent with 30-40 covid patients since Labor Day.

Mr. Grimshaw stated it is still too early to know the severity of the Omicron variant and that they are extremely busy and have no idea when the peak will crest and start downward. The northern part of the state is at an all-time high of cases.

Mr. Grimshaw spoke about the monoclonal antibody infusions. Trinity does perform the infusions, however, there is a waiting list. They are requesting people to call sooner rather than later to request the treatment. Mr. Grimshaw ended with, "we will get through this just not sure when".

Medical Director's Report

Dr. Kissinger stated we are still dealing with Covid unfortunately. When Mr. Grimshaw spoke he talked about the numbers in the hospital and it doesn't always reflect Jefferson County numbers. At the county level, we were roughly around 20 patients or slightly below a week ago. Deaths have increased by three. These may be people that died several months ago but are just being entered into the system. There may also be other cases that we don't have counted because not all other hospital report to us when our patients are in their hospitals.

Emergency department issues; Dr. Kissinger stated there are more beds at Trinity than there are workers to staff those beds due to lack of nurses, housekeeping, dietary and other support staff. These staffing shortages are causing holdovers in the emergency room. The ER holdovers limit the space available to treat broken ankles, hips etc. The holdovers lead to backups of people waiting to be served who enter the emergency department.

In regards to the common cold, flu or covid and getting tested, Dr. Kissinger reported we need to inform the public on what they should be doing before going to the emergency rooms. People should contact their family physician first if they have one. If they don't have a doctor, go to an urgent care center for evaluation first, the urgent care center can then refer them to the emergency room if needed.

Availability of test kits, the Health Department does have test kits for free but they are limited in the amount of tests received. There are test kits for sale in local pharmacies as well. In speaking of tests, Dr. Kissinger stated the test has to be a verified test (proctored) for further treatment such as the antibody infusions. Patients are taking pictures of home tests and sending them in and that is not considered a verified test.

Dr. Kissinger stated approximately 95% of individuals over the age of 18 will qualify for the antibody infusion. People with a BMI over 25 will qualify, which is the majority of the population. The infusion helps reduce the need for hospitalization and deaths. The earlier the treatment the better for the best outcomes.

Omicron variant, there are a lot of unknowns at this time. Omicron has taken over in a very short amount of time and accounts for 75% of our cases. We are just hoping that this variant is milder.

Flu season is just around the corner, just a reminder that the flu vaccine is safe and effective in helping to protect against the flu and keeping the symptoms milder.

With the holidays fast approaching, a reminder to everyone to make safe choices.

Dr. Macedonia spoke about the number of cases in the Cleveland, Akron areas. Their hospitals are experiencing high volume of covid patients.

Dr. Macedonia would like to endorse/recommend not mandate that all public meetings held in the county including city council, chamber meetings, school board meetings, that everyone wear a mask. He is requesting this be sent to all public entities to wear a mask whether they are vaccinated or not to try to protect our citizens.

Mr. Mougianis asked the medical director about the booster and what is recommended. Dr. Kissinger stated it is the individual's choice. Dr. Kissinger stated the data suggests that the J&J booster is not showing as effective, and suggests either Pfizer or Moderna for the booster.

Dr. Macedonia asked about what is considered as fully vaccinated. Dr. Kissinger responded it is mixed at this time. There is nothing official yet that says you have to have three doses to be considered fully vaccinated.

Nursing Report

Nursing Director Hannah Piko asked Angie Bates from the RadX program to speak about upcoming education events she has planned for the community.

Angie Bates stated we are partnering with Jefferson Metropolitan Housing Authority (JMHA), Urban Mission and Ohio Valley Health Center to address vaccine rates and vaccine hesitancy within minorities, the underserved and vulnerable populations. With JMHA we have co-written a covid education mini grant with Urban mission. The emphasis will be on residents who are in low income housing and church and community individuals aged 18 -35 which have the lowest vaccination rate among adults. The health department, as part of the mini grant, will be conducting the education piece and will provide the vaccination if requested. People don't know the when and where. Where to go and when to go to test. This will be a main focus of the education.

Dr. Macedonia asked about the county vaccination rate. Health Commissioner Henry stated we are currently around 46%, we were closer to the 50% mark and then they lowered the age for vaccinations to 5 and older and it changed our percentage. Health Commissioner Henry did state we have the highest percentage as compared to our neighboring counties.

Dr. Macedonia commended Nurse Piko and her staff for the work they have done. He also questioned the number of clients per city report, stating the numbers have doubled. Nurse Piko and Health Commissioner Henry stated this was due to the boosters becoming available and that Trinity has gotten away from holding vaccine clinics and we've taken on a lot of their patients wanting boosters.
