# Audit Update:

Kelly Wilson reported she has been in contact with the auditor and is hoping to have the final audit report prior to the end of the year. Kelly stated there is no guarantee, as of last week she was still getting emails requesting additional information.

### Purchase of All Terrain Vehicle:

Health Commissioner Henry stated we tried to get a quote from a local Kubota dealer and they did not have anything available to us in a four seater. They had a diesel which we are not interested in. In talking with other agencies, there are other county departments that have these type of vehicles. There is training we have found online; however, it would not be specific to the vehicle if we purchase one. The department didn't spend a lot of time researching in the past three weeks as we were unsure about the vote of the board on the purchase. The insurance will cover the vehicle for \$200.00 a year.

Mr. Bell asked if there was a trailer to haul the vehicle and to store it. Rick Stead stated yes there was. Dr. Macedonia asked if there was a windshield and a wench on it. Rick answered a windshield yes a wench no, but we could have a wench added if the board wanted it.

### ServSafe Certification:

Health Commissioner Henry let the board know that at the July 2020 meeting there was a discussion about the ServSafe Certifications. There were several food service operators that did not have the required ServSafe managers certificate. The board decided at that meeting that all food service operators were required to have that certification before December 31, 2020. After



that meeting, there were several changes in staffing at the health department and this was not followed up on.

We currently have 12 food establishments that do not have the level two manager certificate. Three of the 12 are new ownerships and we are working with them. However, the other nine have been open for some time and have yet to get the certification. The Health Commissioner recommends we require the nine outstanding establishments to obtain the certification by January 31, 2023 to be in compliance. The state law requires all level 3 and level 4 establishments to have a food managers certificate. It is a one-time certification that costs approximately \$200.00 and takes two days to obtain. A letter will be sent via U.S. mail, email and a letter delivered in person.
