The Community Health Worker (CHW) will work directly under the Director of Nursing. This position will help apply disease management plans in the context of their community, provide social and emotional support, provide linkage to care, including but not limited to, clinical, community, and mental health services.

The position focus is to serve as a community representative, advocate for individuals and groups in the community by assisting them in accessing community health and supportive resources through the provision of education, role modeling, home visits and referral services. Conducts outreach, facilitates access, and provides culturally appropriate social support, informal counseling, and resources for programs that promote individual and community health; often share ethnicity, language or life experience with the community members they serve (e.g., peer health promoter, lay health advocate, community health representative).

## MINIMUM JOB REQUIREMENTS

Candidates should have a minimum of an associate's degree in a health or education related field. Applicants must be willing to become a certified Community Health Worker (CHW) within one year of employment and participate in the required PreVenture training.

### **ROLES AND RESPONSIBILITIES**

- 1. Assists clients in their community, JCGHD clinic, or home setting. Communicates to clients/patients the purposes of the Pathways program and the impact it may have on their wellbeing. Helps patients identify socio-economic issues that affect their overall health and develop health/social management plans and goals.
- 2. Documents all client encounters and contracts made on behalf of clients; completes and submits monthly reports; maintains comprehensive electronic client files, which include client notes, release of information, assessments and other medical documents acquired on behalf of the client. Documents activities, service plans, and outcomes achieved by client in an effective manner.
- 3. Assists with the With the PreVenture Program, which is a mental health a substance use prevention program, offered in Jefferson County schools throughout the duration of the OneOhio Opioid Grant funding.

- 4. Assists clients in accessing health related services, including but not limited to: obtaining a medical home, providing instruction on appropriate use of the medical home, overcoming barriers to obtaining needed medical care and /or social services.
- 5. Provides support and advocacy during initial visit or when necessary to assure clients' medical needs and referrals required are being conveyed. Follows up with both clients and providers regarding health/social services plans.
- 6. Facilitates communication and coordinate services between providers and the clients/patients. Coordinates and monitors services, including comprehensive tracking of clients' compliance in relation to care plan objectives.
