CALL TO ORDER

Dr. Mark Kissinger, President called the meeting to order at 8:10 a.m. The Pledge of Allegiance was recited and roll call taken. All board members except Suzanne Brown were in attendance.

2026 FEES

Health Commissioner Henry stated no one called to sign up to participate in the public hearing. It would be up to the board if they wanted to entertain anything further in regards to the public hearing.

Dr. Kissinger asked if the gentleman present was here for the public meeting. There was one public participant. Mr. David Ott wanted to know how the fees were determined. Mr. Ott stated he was hoping this would be more of a Q&A session.

Health Commissioner Henry explained to him that the fees are based on Cost Methodology which comes from the Ohio Revised code. The Ohio Department of Health sends each health department a template that is filled in based on costs associated with the food program. The

template from Ohio Department of Health uses different formulas to determine the fee amounts that should be charged in each program. The template is then sent back to the Ohio Department of Health for review and approval after completion by the local health department.


Health Commissioner Henry explained the fee structure to Mr. Ott, followed by a short conversation about the cost of the fees in the food program.


